u/s 323/504/500, 120B of IPC.

Description of the offence:

"The Complainant alleged to had visited the office of the Prabandhak Committee of the Takht Sri Harimandirji Gurudwara, Patna Saheb on 21/9/98 to purchase 3 copies of the Constitution of the Prabandhak Committee and given a sum of Rs.33/- (Rupees thirty-three only) to the Clerk for the same who told that after consulting the manger he would sell the copies to him and went over to the Manager. The Complainant also went to the Manager's room where he saw him talking over telephone with Dr. Pratap Singh, General Secretary of the Prabandhak Committee, and its President, Shri Surendrajit Singh Alduwalia. query of the Complainant for 3 copies of Constitution, the Manager allegedly responded in uncourtious manner and said that he had consulted the General Secretary and the President who told to throw the Complainant out of the office. The Manage and the Clerk misbehaved with the Complainant and allegedly threw him by dragging and abusing before the staff and devotees and also snatched away Rs. 25% from his upper pocket. It was also alleged that Shri Surendrajit Singh Ahluwalia, who was earlier a central government Minister and a wealthy person, was sending threats to him."

The interim order passed on 25/7/2001 by the Hon'ble Paina High Court stated as under:

"This petition has been filed against the order of the organizance taken by the S.D.J.M., Patna City, in Complaint case No. 575 of 1998 (Tr. No. 1178 of 1998) under Sections 323/504/500 and 120B of the Indian Penal Code. It is submitted that against these petitioners practically there is nothing to take cognisance as admittedly they were not present at the scene of occurrence.



Issue notice to opposite party No. 2 to show-cause as to why this petition should not be admitted and disposed of at the admission stage itself. In the meantime, further proceeding in the above-mentioned complaint case in respect of the two petitioners alone shall remain stayed."

Vide its subsequent order dated 1/11/2001, the Hon'ble High Court, Patna, gave the following direction:

"Interim order passed on 25/7/2001 shall remain operative during pendency of this application in the same terms."

Withdrawal of the Complaint Case No. 575(C) 1998:

Further to mention that on 9th March, 2006, the Complainant Dr. Surject Singh filed u/s 257 Cr. P.C. a petition in the Court of S.D.J.M., Patna City, for withdrawal of the complaint case against accused Shri Surendrajeet Singh Ahluvalia. Subsequently, on 13th March, 2006, the Complainant submitted yet another petition u/s 257 Cr.P.C. for withdrawal of the entire Complaint Case No. 575(C) 1998. The Court is closed for Holi holiday and after opening of the Court the above application will be dealt with.
