NOTES FORMING PART OF THE ACCOUNTS FOR THE YEAR ENDING 31ST
MARCH, 2005

1. (a) All the Investments in Shares of Private Limited Companies are held in the individual names of the Party Leaders who in turn have executed disclaimers and lodged them with the General Secretary, National Council.

(b) Share Certificates for the investments in shares of Manisha Granthalaya Pvt. Ltd. Calcutta, Rs. 23,000/-; Navasahitya Printing and Publishing Co. Pvt. Ltd., New Delhi, Rs. 3,50,200/- and Navchetan Books Pvt.Ltd, New Delhi, Rs. 1,00,200/- are not in the possession of the Party.

(c) The last annual report and audited accounts of Mayur Arts Pvt.Ltd, Mumbai and Vanguard Publication Pvt. Ltd., Mumbai in which the party holds shares of Rs. 1,50,000/- and Rs. 25,000/- respectively are reported to be as at 31st December, 1969. The invested Companies have since ceased to do any business and under the circumstance it was not possible to assess the worth of the respective investments of the Party as on 31st March 2005. Hence no provision for the loss on account of diminution in the value of these investments has been made in the books of account as at 31st March 2005.

2. **ACCOUNTING POLICIES:**

The significant accounting policies followed by The Communist Party of India, New Delhi are as follows:

- a) Fixed Assets – Fixed Assets are stated at their Written Down value.
- b) Revenue recognition – The accounts are prepared on historical cost convention based on accrual method of accounting.
- c) There has been no change in any of the Accounting policies since the previous year.
- d) No Income Tax Provision is required as per the Income Tax Act.

3. The accounts of New Age (English) Weekly and Muktisangarsh (Hindi) Weekly are not consolidated in the Party's financial accounts. The Weeklies are making losses for the financial year and separate accounts are audited of the said Weeklies.


4. **Building at Faridabad:**

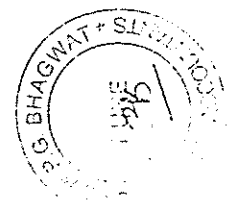

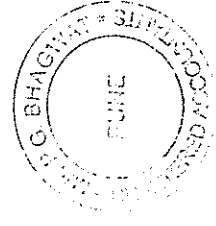
