1. Basis of Preparation:

The financial statements have been prepared to comply in all material respect with the Accounting Standard and Guidance Note issued by the Institute of Chartered Accountants of India. Although these estimates are based upon management's best knowledge of current events and actions, actual result could differ from these estimates.

3. Fixed Assets

Fixed Assets are stated at cost of acquisition. Cost of acquisition of fixed assets is inclusive of Freight, Duties & Taxes.

4. Depreciation / Amortization

No depreciation is provided on fixed asset..

5. Employee Benefits

Remuneration and other employee benefits payable are accounted for on cash basis.
