
I Shri B.M. Lanong son of Late Teresia Lanong of Malki Shillong, do hereby solemnly affirmed and declare on oath as follows :-

2. That I am a lawyer by profession and at present I am a Member of District Council from Laitumkhrah-Malki Constituency.


