 before I Addl. J.F.C.M. No charge was framed in the above crime.

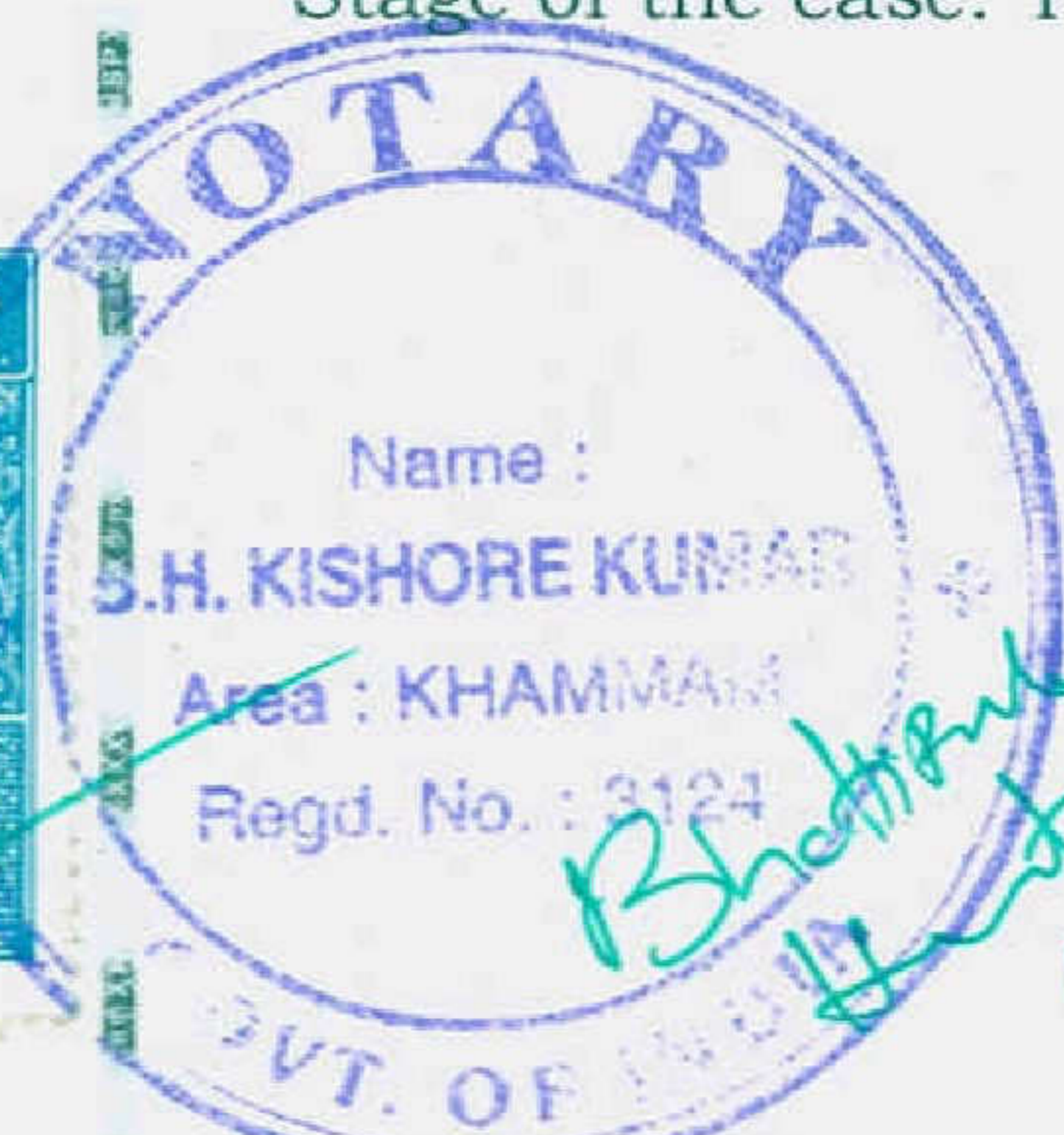
