

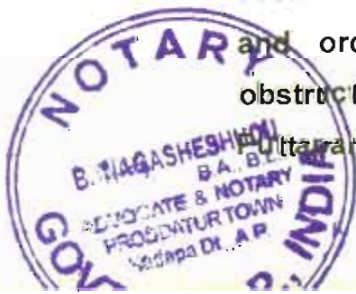

It is alleged that on 9-08-2006 at about 10.30 A.M. to 12.30 P.M., my self and my associates Knowing about the Prohibitory orders of Mandal Revenue Officer, Proddatur were farmed in to an un lawful assembly at Puttaparthi Circle, Proddatur violating the Prohibitory orders of Mandal Revenue Officer Proddatur dated 9-08-2006 and orders of sub divisional Police Officer Proddatur and caused obstruction to the free flow of traffic, and Public caused in convenience at Puttaparthi circle, Proddatur.

C.C.No.149/2008 for the offence under section 151, 188 of Indian Penal Code and Sec.151 of Criminal Procedure Code

Sec.151 of I.P.C:- Who ever Knowingly joins or continues in any assembly of five or more Persons likely to cause a disturbance of the Public Peace, after such assembly has been lawfully commanded to disperse, shall be Punished with imprisonment of either description for a term which may extend to six months, or with fine, or with both.

Sec.188 of I.P.C:- Who ever, Knowing that by an order Promulgated by a Public servant lawfully empowered to Promulgate such order, he is directed to abstain from a certain act, or to take certain order with certain Property in his Possession or under his management, disobeys such direction;

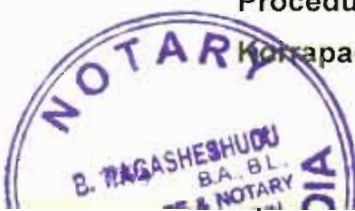
Shall, if such disobedience causes or tends to cause obstruction, annoyance or injury, or risk of obstruction, annoyance or injury, to any Person lawfully employed, be Punished with simple imprisonment for a term which may extend to one month, or with fine which may extend to two hundred rupees, or with both;

And if such disobedience causes or tends to cause danger to human life, health or safety, or causes or tends to cause a riot or affray, shall be Punished with imprisonment of either description for a term which may extend to six months, or with fine which may extend to one thousand rupees, or with both.

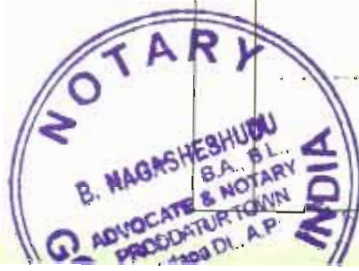

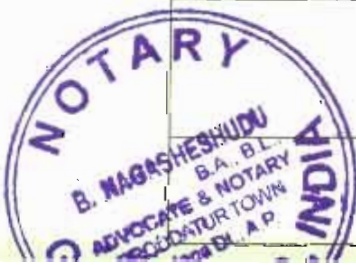
