Abstract of the Judgment of Hon'ble Supreme Court of India dated 11-01-2005 Reg. Interpretation of R.P. Act, 1951 – Sections 8(3) and 8(4) –

1. In the case of convection of a person for more than one offence, in a common trial and with the sentences of imprisonment to run **consecutively**, for the purposes of imprisonment for each offence should be **added** and if the total length of time for which a person has been ordered to remain in prison consequent upon such conviction and sentences is two years or more the convicted person shall be disqualified under the said Section 8(3) of the Representation of the People Act, 1951.
2. The interpretation placed by the Hon'ble Supreme Court on the provision of Section 8(3) of the Representation of the People Act, 1951 would be equality applicable to the provision of Section 8(2) of the said Act.

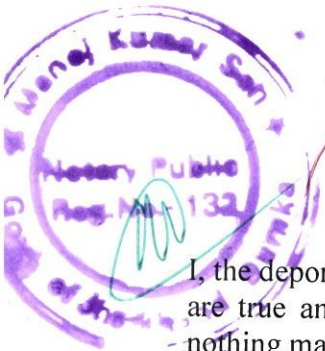
