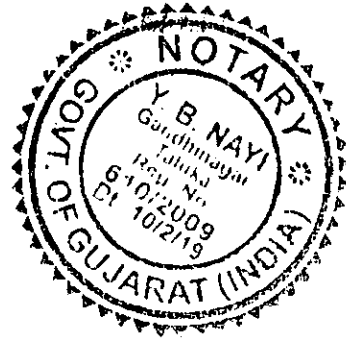




ANNEXURE '1'
